In Wisconsin, Income Maintenance Consortia and Tribal Agencies assist the public with the following.

- Answering questions about your Medicaid (BadgerCare, Medicare Savings Programs, MAPP, etc.), FoodShare, and other program eligibility and current benefits.
- Apply for Medicaid, FoodShare, or other public benefits.
- Process your Medicaid, FoodShare, or other public benefit:
 - o Application
 - Changes
 - o Documents for proof of verification
- Renew your Medicaid, FoodShare, or other public benefits.
- Conduct your FoodShare interview.
